29 Ms. Owens stated that a new Planning Board sub-committee for review of draft Development  
30 Regulation amendments will start meeting in April.

- 1 • City Council – Erling Heistad
- 2 Mr. Heistad did not have items to report.

- 3 • Police Reports - Alan Schnur
- 4 Mr. Schnur reported that in February 2020, police data shows one crash involving ped-bike
- 5 user(s), and that data shows three total such incidents year-to-date, implying that there were
- 6 two crashes in January. No details are available. There was discussion to consider whether
- 7 more or fewer people may be active in walk-bike modes due to COVID-19 and if that may affect
- 8 accident numbers moving forward.

- 9 • Mascoma River Greenway Coalition - Colin Smith
- 10 The Upper Valley Lake Sunapee Regional Planning Commission, including with staff member
- 11 Mr. Belenz's assistance, is spearheading stakeholder outreach and development of a survey to
- 12 complement the state's Rail Trail surveys and planning processes. Chair Smith has observed
- 13 that many people using the MRG practice distancing, to the degree possible, and about half
- 14 seem to be wearing masks. There was member discussion that six feet of distance may not be
- 15 effective particularly for people in motion with high levels of exertion or those coughing.
- 16 Members expressed desire to see more City communications on the issue with possible review
- 17 of updated distancing recommendations and noted that the Recreation Department is a good
- 18 channel for helping to reach out to active people.

- 21 Mr. Belenz noted that the state's Ped-Bike Plan is wrapping up by the end of the summer and
- 22 the UVLSRPC anticipates the opportunity to review a draft soon. The state's lead ped-bike
- 23 staffperson, Larry Kenniston, is retiring and the City will need to find a new primary contact, if
- 24 the state opens up hiring. The UVLSRPC continues to make progress with regional corridor
- 25 surveys and plan drafts.
