 - A. Introductions – Members of the task force introduced themselves and shared thoughts on why they were interested in the subject matter that the task force is engaged with.

The group will aim to have recommendations for the City Council to review by the end of September or early October to allow for the City Council to review the task force recommendations prior to the ordinance’s effective date of January 1, 2021.

 - Purpose, Intent, Titles & Definitions
 - Provision 1 – language regarding data collection
 - Provision 3 – issue of voting
 - Provision 6 – notification by City
 - iii. Types of input desired – The group brainstormed desired input and created the following list:
 - Affected community members
 - Other local communities (e.g. Hanover and Hartford)
 - Other cities (e.g. Chicago)
 - Experience of people who have lived with a similar ordinance for a length of time
 - Police

i. Develop list of questions for Legal Counsel, Police Chief, and others – The group identified the following questions as a place to begin:

- Is the city in jeopardy of losing federal funding?
- What are the consequences?

- What are the elements of other ordinances?
- Who is critical of what we have done? Why?
- Arguments on both sides (people who feel we have gone too far, people who feel we have not gone far enough)
